# COMMUNITY VISITORS SCHEME

**Through the Community Visitor Scheme (CVS) program SCAA has been working actively in the community and has collaborated with various service providers in order to identify and provide companionship to socially isolated seniors in the Serbian community.**

Due to the COVID-19 pandemic, our CVS project witnessed increased sense of loneliness and isolation, not only amongst the care recipients, but also amongst its volunteers.

Maintaining video conversations was difficult nevertheless, telephone conversations were very well accepted.

Further, the volunteers' connections with the home care recipients they were visiting were impacted for long time. Hence the project had to provide additional support in order for them to re-connect with the recipients of the home care packages, in order to continue their face-to-face meetings.

Prolonged lockdown and restrictions imposed by the Government prevented volunteers from visiting the residents in the aged care facilities in person.

However, having phone calls is of great benefit for the residents but then again, the facilities are usually short staffed and there is no available worker who can take the phone to resident or to stay with them to help navigate the phone or device.

Recruiting volunteers to visit elderly at the RACF has become a challenge as every facility implemented different set of rules and requirements for visitation and this was also changing frequently. However, the benefits of the programs have been evident as the isolated people involved have reported on feeling less isolated and more included in the community.

They have developed friendship and companionship, have had someone they can talk to, understand them and someone to rely upon. In addition, the volunteers have regularly commented on the great deal of satisfaction they receive in helping someone.

# EMBRACING PEOPLE LIVING WITH DEMENTIA IN THE SERBIAN COMMUNITY

**The Embracing People Living with Dementia in the Serbian Community project was funded through the Dementia Friendly Communities Community Engagement Program.**

The aim of this project was to increase awareness of dementia amongst the Serbian community, to both gain an understanding of the condition, as well as to build better relationships with those people living with dementia.

Due to COVID-19 pandemic the project experienced multiple barriers and had to be extended twice in order to achieve the set targets. Easing the COVID related restrictions have provided opportunity for people to become active in the community and has enabled the project to continue with its activities.

The project managed to identify and engage champions who assisted the Association in gaining the recognition and resources needed to achieve short-term and long-term goals aimed at supporting people with dementia and improving their wellbeing.

During 2021/22 the project organised several outings for people with dementia and delivered a series of information sessions to the members of the Serbian community.

This valuable project has enabled the Association to improve understanding of the symptoms and causes of dementia amongst the members of the Serbian community.

In addition, it provided an opportunity for people with dementia and their carers to participate in the activities tailored to their needs and also to include them into existing activities in the community.

# SUPPORTING CARERS LOCALLY GRANTS PROGRAM (ROUND 2)

**The project provided the Serbian speaking carers in the City of Greater Dandenong and City of Brimbank, with an opportunity to get together, share their experiences and take some time for themselves.**

The particular emphasis of this project was the inclusion of carers who are elderly themselves and who find the carers role difficult.

The project activities planned to include regular meetings and peer support, recreational activities such as walking groups, tai chi or similar and outings.

However, due to the COVID-19 pandemic the project experienced some challenges in the first half of the project when planned activities had to be postponed due to restrictions being imposed. Nevertheless, during this time the project maintained regular contact with the identified carers and was able to monitor the health and wellbeing of the carers ensuring they were receiving important messages regarding COVID-19.

Following the easing of restrictions, the project resumed with the planned activities, which have been modified to address the current needs and spirit amongst the carers.

As requested by the carers during the summer months the project organised mainly outdoor activities.

The project provided the carers with a social setting that has enabled them to reconnect with others and provided them with the opportunity to take time for themselves.

Providing a social setting for carers enabled them to make new connections, expand their own support network, allowed them to share their feelings with others and gain some practical skills and knowledge.

Through this project the carers reported feeling more supported and cared for and noted that they had gained confidence and capacity to provide care.

# ADDITIONAL CARER RESPITE FUNDING 21/22

**Through the Additional Carer Respite Funding 2021-22, SCAA has provided respite services to carers of Serbian background.**

Throughout this project we worked with the carers whose needs varied, ranging from limited support to those with more complex issues. Majority of the carers involved in this project were caring for people who were mobile and able to communicate. As such the respite services were organised in advance and carefully planned.

The majority of carers were mainly interested in having shorter breaks where the person they cared for could be supported in their home or in the community for an event or outing. Therefore, regular outings in local parks as well as morning tea and luncheons were organised as part of this project.

The Additional Carer Respite program has been exceptionally well received by the Serbian speaking carers. Although the majority have never utilised any respite services and were not very familiar about the program in a short period of time, they become accustomed and started utilising the service. The number of carers involved in this program has grown in a short period of time.

According to their feedback offering services in their language, and having the service tailored to suit their needs and being culturally appropriate, made them more conformable about participating in this program.

# SOCIAL CONNECTIONS FOR BETTER HEALTH AND WELLBEING OF SERBIAN WOMEN PROJECT

VicHealth is providing funds through the Reimagining grants program, for community led projects that support better health and wellbeing of Victorian communities.

Amongst the funded projects in 2021/2022 was the “Social connections for better health and wellbeing of Serbian senior women” project, which aims to improve health and wellbeing amongst the Serbian senior women living in the City of Greater Dandenong.

In response to the diverse needs of these women, and in order to enhance participation in the broader community and improve the quality of their lives, the project organises regular meetings and social and recreational activities.

The project provided an enjoyable and interactive program which encourage the senior women to become more active and feel more integrated into community.

## SCAA GROUPS

**As in previous years the SCAA continued to support the Dandenong Serbian Senior Women’s group and the Serbian Playgroup.**

Due to the COVID pandemic and social restrictions imposed the face-to-face meetings were not allowed. However, the SCAA maintained regular contact with the members of these groups and regularly provided the members with the most current information regarding COVID-19 and offered continuing social support.

From February 2022 these groups resumed the face-to-face meetings, which brought much amusement and joy to everyone involved.

I have reviewed the accompanying financial report of Serbian Community Association of Australia Inc., which comprises the statement of financial position as at 30 June 2022, the statement of comprehensive income, statement of changes in equity and statement of cash flows for the year ended on that date, notes comprising a summary of significant accounting policies and other explanatory information.

**Board's Responsibility for the Financial Report**
